



## Seattle Prep Transportation Contract 2022-23

Seattle Prep is pleased to continue offering morning-only Shuttle transportation from North Seattle, West Seattle, South Seattle and the Eastside to our families. The yearly cost (**includes** \$100 non-refundable deposit) is \$936 for the North Seattle, West Seattle, South Seattle routes and \$1056 for the Eastside route. Charges are posted to your student's Auxiliary Charge on a quarterly basis (December, March, and June). **The West Seattle Afternoon Shuttle will operate until the West Seattle Bridge opens. Once the bridge opens, the afternoon shuttle will operate through the end of that month.**

A \$100 non-refundable deposit is paid separately with the completed contract. A limited amount of assistance is available for students who qualify. Contact Manny Ovena for information regarding transportation assistance. Student shuttles run each morning, including late starts, half-days and testing days.
